Proposal for Club Constitution Rule Change

20.0 Provision for Appointment of Honorary Admiral

- 20.1 At a General Meeting the Members may appoint an Honorary Admiral by ballot. The appointed Honorary Admiral shall serve for a continuous period of three years in that office and subsequent to this they shall not be eligible for re-appointment to the position of Honorary Admiral but will be eligible for election as an officer of the Club or to membership of the Management Committee.
- 20.2 Members may propose a Candidate for the position of Honorary Admiral to the Management Committee. This Candidate shall be proposed and seconded by Members with full privileges (as defined in Rule 3.1) and the proposal shall be submitted to the Club Manager before the end of July in any year for consideration at the next Management Committee meeting. The Proposer and Seconder shall be present at that Management Committee meeting alternatively a letter must have been written to the Club Manager by the Proposer and the Seconder as to the suitability of the Candidate. The Management Committee shall agree on the person or persons to be nominated to the Annual General Meeting for consideration of appointment. The nomination(s) for the Honorary Admiral and the process for appointing the Honorary Admiral at the AGM shall follow the same principles as those laid out in Rule 21.1.
- 20.3 The Honorary Admiral may be invited to attend Management Committee meetings but shall not be entitled to vote.

21.0 Election of Officers and Management Committee

21.1 The election of Officers, Admiral and other members of the Management Committee shall, subject to the provisions of this rule, be effected by ballot of those present at the Annual General Meeting. The name of a Member willing to serve shall be notified in writing not later than noon on the twenty-eighth day before the meeting, with the name of the proposer and seconder and a declaration of interest in and willingness to serve on at least one of the currently existing Sub Committees, to the Club Manager who shall post the same in the Clubhouse. Following the posting of the notice in the Clubhouse, the Club Manager shall communicate the notice to all Members by email or letter, together with the notice of the date and time of the Annual General Meeting. Only Members with full privileges (as defined in Rule 3.1) may be elected as an Officer or appointed to serve on the Management Committee and such Members shall have been a Member (as defined in Rule 3.0) for at least two years. If there is only one nominee for each post then they shall be elected without a ballot.
